

One purpose of this newsletter is to keep our employees up to date on what’s happening, but another one is to try to keep everyone safe as well. If you notice something that might be a concern for people to be aware of, then please be sure to bring it to our attention, and if appropriate we will put it in the newsletter. Please be sure to look through these. If it’s of concern to one person, then maybe there are more out there who are just as concerned:

- ☞ First change is that no more personal information can be given out over the phone. This means that we cannot give out addresses, telephone numbers, etc. to anyone any more. The reason is because of the HIPAA laws and privacy violations if we do. What we can do is if someone needs that information, let us know what you need, and we can forward your request to the person you are trying to reach. We understand frustration, but it’s the law and we have to follow it.
- ☞ Please remember that **no popcorn** is allowed anymore. Someone brought some again recently, and they burned it. 3 fire trucks and 45 minutes later, we were able to go back to work.
- ☞ A parent told me today that they saw someone parked in the lot over at Schubert’s Furniture, our next door neighbor, who was in a rush to get out and drove over Schubert’s grass. Please, please, please, everybody, Schubert lets us use their lots out of the goodness of their hearts. Any time this privilege gets abused like this, they have the right to allow no parking on any of their lots. 


