To recognize National Disability Employment Awareness Month, contract packager Lafayette Industries showed appreciation to local business partners, local government officials and other community representatives with a breakfast, employment champion awards and tours of the work floor at its Manchester facility.

Lafayette Industries, which also has a north production facility in Berkeley, is a nonprofit packaging, assembly and mail fulfillment business. It was founded in 1976 by 16 individuals

seeking employment for their grown children with developmental disabilities. Today, Lafayette employs more than 400 adults with developmental disabilities.

"As Missouri's single largest full-time employer of adults with IDD [intellectual developmental disability], we thought it appropriate to honor and thank the great companies in the area that enable us to employ so many people during National Disability Employment Awareness Month," Rob Libera, Lafayette Industries' CEO and executive director, said. "We also wanted to thank our civic leaders and elected officials in Manchester and St. Louis County for constantly demonstrating their support."

I.V. House, which was founded in 1991, patented a dome-shaped, clear plastic protective house that is placed over I.V.s and prevents children from dislodging the I.V. Lafayette Industries does 80% of the assembly of I.V. House's packages.

"I really enjoy the people I work with here," John Uhlenbrock, director of operations for I.V. House, said. "We feel good about supporting Lafayette Industries, and they do a great job for us. So it's a win-win." Six Lafayette West workers – Alison Hanners, Casey Florent, Roman Pfeiffer, David Pfeiffer, Kurt Pfeiffer and Allison Pfeiffer – led the building tours.

"They're so proud of what they do here," Debbie Franke, of Enterprise Bank, said. "It just makes you feel good that we recognize, as a society, what these individuals are capable of. It's a beautiful thing."

#### SAFETY TIP FOR DECEMBER 2019

Pallets. A fact of all manufacturing plants. A necessity for sure. **BUT:** 

They bring with them a long list of safety issues that have been a focus at Lafayette for years.

Of course they are the #1 tripping hazard at Lafayette, and are constantly mentioned to the employees. Orange safety cones are used regularly to mark their presence. If an orange safety cone is not available, then use trash cans, boxes or any object of size that can be placed on the pallet.

We have rules concerning them – how high to stack them, not to stand them on end nor to stand on them ourselves.

Blue barrels are placed around the shop to collect broken boards and large splinters.

Some of the pallets are extremely heavy, so we encourage two people to carry them.

Pallets are essential to our operation, but safety considerations are a must.

#### BEGINNING TAX RECORDS COLLECTION



As your tax forms arrive collect all income forms (W2, 1099R, Social Security, SSI Letter, Interest, Dividends, Capital Gains), adjustments to income (IRA contribution, student loan interest, etc.), Real Estate Tax receipts, rent receipts, proof of medical insurance and premium expenses (forms 1095A or B), and if you itemize (mortgage interest, charity gifts including volunteer mileage and expenses, medical expenses

including mileage). Don't forget to request your 2019 Required Minimum Distribution if you are over age 70½. Also needed for each person listed on the tax return is a driver's license or state photo ID, Social Security card, proof of age, direct deposit account numbers and a copy of last year's tax return.

Many Lafayette employees owe no tax but may be eligible for the Earned Income Tax Credit and possibly the Missouri Property Tax Credit (Circuit Breaker). A review of the employee's income and disability status determines eligibility for the earned income credit. The Property Tax Credit must have a real estate tax receipt, or a statement of rent paid from the landlord and proof of disability. Federal income, state income and property tax credit (if applicable) forms are completed as one package.

If you are over 70½ don't forget to take your IRA Required Minimum Distribution, and if you contribute to an ABLE account that must be done before December 31<sup>st</sup>. Those needing an IRS identity PIN should receive it in December. Tax returns will be completed on the IRS computer tax preparation system, and efiled with the IRS. This free tax preparation service is offered by the AARP Tax Aide Foundation.

#### CARLI BINEK PARTICIPATES IN ALZHEIMER'S RESEARCH STUDY

Carli Binek is the first participant in the Washington University portion of an International research study to learn more about adults with Down syndrome and the important role they play in understanding Alzheimer's Disease. The name of the study is Neurodegeneration in Aging Down syndrome. The study is conducted by Dr. John Constantino and Dr. Beau Ances at Washington University. Other sites include Cambridge in the United Kingdom, Madison, Wisconsin and Pittsburgh, Pennsylvania.

This is a five year study. The findings from this study will be compared with the findings from similar studies of other subjects without Down syndrome. The long-range goal of the study is detecting the early onset of Alzheimer's before the symptoms appear.

The study includes three parts: a psychology evaluation, a MRI scan and PET scans. These three protocols will be repeated every sixteen months for five years. Carli is excited to be participating in the study and being able to make a major contribution to finding a cure for Alzheimer's Disease.

**REAL ID-COMPLIANT:** You may have heard about the Real ID for some time now in the state of Missouri. We had an article about it several months back in our newsletter. We even listed some of the items that you would need to take with you when you got it at the DOR. Missouri has managed to postpone the Real ID compliance for several years, but now time is running out for everyone to get over to the Missouri Department of Revenue office and get one. As of October 1st it will become law that you have to have a Real ID or you'll have to carry extra documentation with you when going to certain Federal places in order to gain entrance. These places would include boarding an airplane, entering Federal courthouses and admittance to military bases. If you wish to get the Real ID, go to dor.mo.gov>drivers>documents>RID. There you'll find the lists of documents that you'll be required to bring with you to obtain the Real ID. There will be a cost in the changeover, but Missouri will let you use your current ID picture for your new ID, if you wish. The only difference between your old license and the Real ID is a gold star in the upper right-hand corner. If you have a license that has some time to go before expiring, the cost of the changeover will be minimal – about \$12 or so. It took about a week to get the new license, but the longer you wait, the longer the lines are going to get and the longer you have to wait to get it through the mail. But getting your supporting documentation correct the first time will save you an extra trip later. Be sure to read carefully and make sure that what you have is If you don't have the precisely what they request of you in order to get the Real ID. documentation, you will be making an extra trip to the DOR. Good luck, everybody. Remember that October 1st will be here before you know it.
